The Project Officers would be required to -

- 1. Report at SPA Vijayawada campus in person during the period of engagement
- 2. Undertake report writing, formatting, conduct literature review and data analysis.
- 3. Facilitate communication among stakeholders, including government agencies and research team, to gather inputs and foster engagement for the project.
- 4. Go on site-visits, conduct or supervise primary / secondary surveys, whenever required.
- 5. Collaborate with team to achieve project objectives timely.
- 6. Arrange stakeholder meetings and workshops as and when required.
- 7. Make presentations, as and when required.
- 8. Any other work, assigned from time to time.

### **Terms and Conditions**

- Interested candidates fulfilling the qualification requirements as mentioned above can apply online, within the deadline of Jan 11<sup>th</sup> 2025, 5PM by filling the online application forms available at - <u>https://acupcb.spav.ac.in/work-with-us/</u>.
- 2. Applicants should upload all necessary documents, portfolio, and writing samples, as desired in the application form. Any application, which is incomplete in any sense, is liable to be summarily rejected.
- 3. A candidate wishing to apply at multiple positions; need to apply and fill the forms separately for each project, by uploading all necessary documents separately, within the stipulated deadline.
- 4. Shortlisted candidates will be called for an online interview and the exact dates for the interview shall be communicated to the applicants.
- 5. Candidates having prior in-depth knowledge in the themes of the projects, and who have worked in the relevant themes or have relevant practical experience, are desirable.
- 6. Candidates, if selected, require to join the project team and report to the project leader, within a week of announcement of results.
- 7. An application by a candidate, who fulfils the minimum eligibility criteria, may still be rejected by Competent Authority without assigning any reason whatsoever.
- 8. The engagement for this notification in the said positions as given in page 1, table 1, is purely contractual and temporary, wherein the appointed officers shall ne hired specific for the projects. The engagement is not for the recruitment directly under the A-CUPCB-SPAV, but only for the projects.
